## Assessment and completion

Students' knowledge is assessed by means of practical exercises and seminar papers, and also via products, projects, performances, services, etc. and by examinations. Examination performance is graded as follows: 10 (excellent); 9 (very good: above-average knowledge but with some mistakes); 8 (very good: solid results); 7 (good); 6 (adequate: knowledge satisfies minimum criteria); 5–1 (inadequate). In order to

pass an examination, a candidate must achieve a grade between adequate (6) and excellent (10).

## **Progression**

Students progress to the second year when they acquire at least 45 credits in first-year subjects, and to progress to the third year they must have at least 45 credits from the second year and have passed all first-year examinations (except work placement).

## **Transitions**

Second-cycle master's study programmes (SQF level 8)

## **Condition for obtaining certificate**

To complete their studies, students must complete all course units prescribed by the study programme and successfully present their diploma thesis.
