The qualification holder will be able to: General competences:

- comprehensive insight into the development of modern humanities and culture and society in general,
- an overview of the broad and diverse regional cultures, forms and ways of life,

- a systematic overview of thematic sections, each of which analyzes social and cultural experience from its own point of view, from elements of material cultural tradition to fundamental religious and other spiritual phenomena,
- work in the field of humanities and culture, which forms and distinguishes profiles of eminent regional, national and international staff responsible for the management of culture and politics,
- performing independent and cooperative research work in the field of humanities and social sciences, counseling in institutional units of the central and local level of the state, counseling and work in cultural institutions, civil society institutions, publishing houses, magazines, work in television and radio and other modern media,
- development of communication skills, critical appraisal and creation of independent written texts (articles, papers, discussions, etc.),
- independent study, critical assessment of current social and political events, interpretation and evaluation of political and social phenomena,
- developing critical and self-critical judgment that will contribute to the objectivity of the results achieved,
- commitment to professional ethics and ethical reflection, especially with regard to the issues of ethnic groups and the related understanding of the values and concepts of protection of persons and social groups and "human rights",

- an overview of the regional cultural space at the crossroads of different ethnic groups, cultures and identities, in all their diversity and intertwining,
- knowledge of ethnological theories on the formation of the Slovene ethnic space in contact with neighboring areas,
- understanding the internal and external movements of past and contemporary disciplinary identity,
- knowledge of the theory, methodology and results of ethnological and anthropological research of social culture in Slovenia and abroad and their terminology, theoretical concepts and methodologies,
- independent research of cultural phenomena and taking into account the cultural diversity and diversity that characterize the regional space,
- knowledge of methods of collecting, evaluating and interpreting data obtained in the field or in the literature and designing texts and videos for publishing results,
- involvement in other humanities and social sciences studies or in cultural, political and social science work of an interdisciplinary nature in the study of the way of life, creation and thinking of different ethnic groups,

Subject-specific competences:

- understanding of various social, cultural and ethnic groups and individuals,
- independent interpretation of various social, cultural and ethnic groups and individuals,
- independent connection and transmission and translation of information from the mentioned fields,
- understanding and evaluating information (he is used to quickly interpreting, contextualizing and simplifying information and making it understandable to the general public),
- multicultural and intercultural competences (successfully moves between different cultures and feels at home in multiethnicity),
- understanding and professional and managerial assistance in solving social problems (aging,

conflict, alienation, disease, migration ...),

- synthetic interpretive connections between field and theoretical study of cultural phenomena,
- versatile communication and literature (knowledge of people's habits and their interpersonal relationships, the world understands through several languages and several cultures),

- in-depth knowledge and understanding of the origin, history and justification of cultural studies,
- knowledge and understanding of the general structure of cultural studies and anthropology, their interrelationships and relations with their subdisciplines,
- coherent mastery of basic knowledge in the field of cultural studies and able to connect them with knowledge from other fields,
- solving specific problems that will be posed to him at work, and he will be able to use the relevant knowledge, scientific methods and skills acquired during his studies,
- placement of new information and interpretations in the context of cultural studies or anthropology,
- application of the critical analysis method,
- understanding the development of various theories in their field and other relevant areas and able to use these theories in solving specific work problems,
- use of the latest information and communication and media technology relevant to the field of cultural studies and anthropology,
- knowledge of the cultural regionalization of the Slovenian ethnic territory, with an emphasis on the Mediterranean part of Slovenia,
- insight into the identification of ethnological aspects of individual components of material heritage, their proper evaluation and knowledge of normative orientations in this field,
- knowledge of the theory and methodology of ethnological study of social culture (family, kinship, neighborhood) in individual places and regions (Istria, Kambreško, Venetian Slovenia, Kanalska dolina, Ljubljana, Prekmurje, Porabje) in the 20th century,
- production of field visual documentation in research work, including recording, inventory, storage, analysis and interpretation,
- processing and editing of documentary material (documentation, compilation of chronologies, classification, indexing), analysis, interpretation and applications of biographical material (in school, museums, media),
- knowledge of the practice of ethnological departments of museums, institutes for the protection of cultural heritage and research institutions and minority scientific and cultural institutions in Istria and Italy,
- understanding the spatial aspects of heritage, understanding and recognizing spatial laws in specific environments and learning about experiences for cooperation in spatial management,
- knowledge of the guidelines of the educational programme of the organization ICOMOS from Colombo 1993 for coordinated interdisciplinary education of various disciplines of participants in competent work with heritage.

#### Assessment and completion

Examination performance is graded as follows: 10 (excellent); 9 (very good: above-average knowledge but with some mistakes); 8 (very good: solid results); 7 (good); 6 (adequate: knowledge satisfies minimum criteria); 5–1 (inadequate). In order to pass an examination, a candidate must achieve a grade between adequate (6) and excellent (10).

### **Progression**

To progress to the second year, students must complete study obligations in the amount of at least 54 ECTS, and must complete all basic subjects of the chosen field.

Third-cycle doctoral study programmes (SQF level 10)

#### **Condition for obtaining certificate**

To complete the studies, students must complete all the obligations prescribed by the study programme.
