Admission requirements

- A completed first-cycle (Bologna) study programme or an earlier study programme leading to a professional higher education qualification in a relevant field (under the Frascati classification this means: social sciences, business and management, natural science and mathematics, medicine and humanities) and at least 180 ECTS credits; or
- a completed study programme from the previous indent in another field not included in the previous paragraph and at least 180 credits; the additional course units totalling 12 credits which candidates must complete before enrolling in this master's programme are Microeconomics 1 (6 credits) and Introduction to Business (6 credits).

Learning outcomes

The qualification holder will be able to:

- demonstrate familiarity with the quantitative methods necessary for economic analyses in this field.

Assessment and completion

Examination performance is graded as follows: 10 (excellent); 9 (very good: above-average knowledge but with some mistakes); 8 (very good: solid results); 7 (good); 6 (adequate: knowledge satisfies minimum criteria); 5–1 (inadequate). In order to pass an examination, a candidate must achieve a grade between adequate (6) and excellent (10).

Progression

In order to progress to the second year, students must complete all study obligations at exams he / she has enrolled in the first year. Committee responsible for the study programme (Student Affairs Committee) of the Faculty of Economics, University of Ljubljana may exceptionally lower the promotion criteria and / or allow promotion of a student who has not fulfilled the above criteria but who has justified objective reasons for this (Article 153 of the Statute of the University of Ljubljana).

Condition for obtaining certificate

In order to complete the study programme, the student must complete the study obligations in all subjects of the enrolled study programme and successfully defend the master's thesis, in accordance with the

provisions of the Rules on the master's thesis, adopted by the Senate of the Faculty of Economics, University of Ljubljana.
