## Admission requirements

- A completed first-cycle study programme in a relevant field consisting of at least 180 ECTS credits (under the Bologna system); or
- a completed study programme leading to a professional higher education qualification in a relevant field, offered between 1 January 1994 and 11 June 2004; or
- a completed first-cycle study programme or programme leading to a higher education qualification offered between 1 January 1994 and 11 June 2004 in another field, where prior to enrolment candidates must pass differential examinations consisting of between 16 and 24 credits set by the academic affairs committee with regard to the field of previous study.

## Learning outcomes

The qualification holder will be able to:

(general competences)

- be innovative and creative,
- analyse, synthesise and anticipate solutions and consequences,
- master research methods, procedures and processes, develop critical and self-critical assessment,

- demonstrate mastery of research methods, procedures and processes in the fields of law and social sciences and develop critical and self-critical assessment in the field of immovable property management, law, economics, organisation, architecture, urban planning, sociology, psychology, marketing and organisational culture,

- place new information and interpretations in the context of development of the profession in the fields of law and immovable property management,
- develop skills and expertise in the application of knowledge in the field of immovable property,

- demonstrate understanding and mastery of legal knowledge that is closely related to the fields of immovable property, ownership, the economy, the environment, etc.,
- demonstrate understanding of the concept of immovable property in the sense of the integration of social science, humanities and engineering disciplines,
- analyse, synthesise and envisage solutions and the consequences of phenomena in conditions of international legal transactions in the immovable property field,
- demonstrate understanding of the urban planning and architectural principles of immovable property environment and interdisciplinary thinking in the case of investment planning,
- apply techniques and methods of project management in a practical case,
- use economic tools for business decisions,
- apply interdisciplinary knowledge in unpredictable immovable property and business situations in the EU environment,
- critically select principles for addressing specific work problems within an immovable property environment.

## Assessment and completion

Examination performance is graded as follows: 10 (excellent); 9 (very good: above-average knowledge but with some mistakes); 8 (very good: solid results); 7 (good); 6 (adequate: knowledge satisfies minimum criteria); 5–1 (inadequate). In order to pass an examination, a candidate must achieve a grade between adequate (6) and excellent (10).

## Progression

Students may progress to the next year if by the end of the academic year they have completed all requirements defined by the study programme for progression to the next year.
