#### **Learning outcomes**

- The qualification holders have in-depth knowledge in the area of the general theory of social work and are trained to apply it in the field of enforcement of penal sanctions.
- Equally, they have in-depth knowledge in the field of penology, the nature of individual institutions for enforcement of penal sanctions and the forms of non-institutional enforcement of penal sanctions.
- They have acquired in-depth knowledge in the field of theories of social deviations and supervision, and are trained to apply them in the field of social work.
- They have also enhanced their knowledge in the field of deviancy, phenomenology and symptomatology, the possibilities for helping individuals, their families and the wider social environment, and have acquired practical knowledge and skills for communicating with people dealt with in the penal system in institutional and non-institutional procedures.

# **Assessment and completion**

Examination performance is scored as follows: 10 (excellent); 9 (very good: above-average knowledge but with some mistakes); 8 (very good: solid results); 7 (good); 6 (adequate: knowledge satisfies minimum criteria); 5–1 (inadequate). In order to pass an examination, a candidate must achieve a grade between adequate (6) and excellent (10).
