# **Assessment and completion**

VALIDATION. During the counselling process, the candidate prepares a portfolio. The relevant committee assesses the portfolio and recognises the catalogue content in part or full. If the committee is unable to recognise all catalogue content, it assigns tasks to the candidate for verification.

VERIFICATION METHOD. Service with an oral presentation.

## **Condition for obtaining certificate**

A candidate demonstrates the attainment of the knowledge, skills and competences defined in the

catalogue of standards of vocational knowledge and skills.

# **Awarding body**

Providers of procedures for identifying and validating national vocational qualifications are entered in a register of providers maintained in the relevant collection of the National Reference Point for Occupational Qualifications. Providers include: vocational schools, companies, inter-company training centres, adult education centres, chambers of commerce, etc.
