Learning outcomes

The candidate is able to:

- plan, prepare, carry out and control their own work, taking care of keeping appropriate documentation,
- to ensure the quality and thus the financial performance of its work and products, while respecting the principles of rational use of energy, time and materials,
- make auxiliary structures and formwork,
- design, manufacture and install wooden load-bearing structures (skeletal structures, roofs, wooden load-bearing walls, area walls, stairs),
- design, manufacture and assemble elements of drywall buildings and wooden elements by hand or using woodworking machines (classic and CNC machines),
- to protect wooden structures using various means and technologies of processing and to carry out rehabilitation and maintenance works,
- cover roofs with roofing made of different materials,
- plan and implement practical education of students and introduction of new employees in the company (content, methodological, didactic and technical),
- independently organize and manage employees in their business unit, taking into account regulations in the field of labor law, rules of teamwork and management skills,
- communicate independently with employees and business partners, taking into account the principles of successful communication and business etiquette using modern information and communication technology,
- comprehensively and responsibly manage and monitor the implementation of regulations and standards regarding safety and health at work and environmental protection principles in its business unit.
- monitor the work processes in its business unit to achieve quality standards and implement

- measures to improve quality in accordance with the standards and strategy of the business unit,
- to ensure the profitability of the business unit in cooperation with other services, taking into account the legality of the business environment and regulations in the financial and economic field.

Accessors

Members of examination boards for each examination unit separately. Appointed by the minister responsible for education. Appointment may be renewed every 4 years.

Assessment and completion

Candidates sit a master craftsman examination, which consists of four units:

- a practical unit,
- a technical and theoretical part,
- a business and economics part,
- an education part.

Condition for obtaining certificate

Candidates must pass all four units of the master craftsman examination to receive the title of master craftsman.
