#### Learning outcomes

The candidate:

plans own work and prepares the workplace taking into account the programme of work,

#### Accessors

Verification and assessment are carried out by committees for the verification and validation of national vocational gualifications, appointed by the National Examination Centre (NEC). Committee members must be licensed by the National Examination Centre. Licences may be found here .

#### **Assessment and completion**

#### VALIDATION

During the counselling process, the candidate prepares a portfolio. The relevant committee assesses the portfolio and recognises the catalogue content in part or in full. If the committee is unable to recognise all catalogue content, it assigns tasks to the candidate for verification.

METHOD OF VERIFICATION

Practical verification with an oral presentation.

### **Condition for obtaining certificate**

The candidate demonstrates attainment of the knowledge, skills and competences defined in the catalogue of standards of vocational knowledge and skills.

### **Awarding body**

Providers of procedures for identifying and validating national vocational qualifications are entered in a register of providers maintained in the relevant collection of the national reference point for vocational qualifications. Providers include: vocational schools, enterprises, inter-enterprise training centres, adult education centres, chambers of commerce, etc.
