## Learning outcomes

Candidates will be able to:

- plan, prepare, carry out and check own work and the work of others,
- make rational use of energy, material and time,
- protect life, health and the environment,
- communicate with co-workers and the environment and work in teams,
- prepare personal equipment, an armoured vehicle and technical equipment,
- handle and maintain personal weapons and equipment,
- participate in international military operations and protection and rescue missions and provide security,
- maintain weapons, ammunition, mines and other explosive devices, and other material and technical resources,
- handle and maintain section-level weapons and equipment,
- operate an armoured vehicle and implement tactical procedures in a combat zone,
- prepare and inspect an armoured vehicle,

- drive an armoured vehicle,
- use communications devices.

## Accessors

Verification and assessment are carried out by committees for the verification and validation of national vocational qualifications, appointed by the National Examination Centre (NEC). Committee members must be licensed by the National Examination Centre. Licences may be found [here](#).

## Assessment and completion

### VALIDATION

During the verification procedure, the candidate will prepare a personal portfolio with the help of Armed Forces personnel support. This will be evaluated by a committee and the content recognised in full or in part. In the event that the committee is unable to recognise all catalogue content, it assigns tasks to the candidate for verification.

### VERIFICATION METHOD

Practical testing.

## Condition for obtaining certificate

Candidates demonstrate attainment of the knowledge, skills and competences defined in the catalogue of standards of vocational knowledge and skills.

## Awarding body

Providers of procedures for identifying and validating national vocational qualifications are entered in a register of providers maintained in the relevant database of the National Reference Point for Occupational Qualifications. Providers include: vocational schools, companies, inter-company training centres, adult education centres, chambers of commerce, etc.
