After five years of its establishment and the placement in the European Qualifications Framework for Lifelong learning, Slovenian Qualifications Framework is facing new challenges. As other national qualifications frameworks in the stage of their active implementation at the national level, it is faced with the question of its impact and added value for different groups of stakeholders.

These issues are closely related to the challenge of evaluating and measuring the impact of national qualifications frameworks. Slovenian National Coordination Point for EQF in cooperation with the European Center for the Development of Vocational Training (CEDEFOP), runs the activity of monitoring the implementation of the Slovenian Qualifications Framework.

The event is primarily intended for all key stakeholders with an active role in the implementation and application of the Slovenian Qualifications Framework in practice, which will collaborate in the future evaluation of the Slovenian Qualifications Framework.

Moreover, the event also presents an opportunity for other EQF NCPs, in case they are planning the evaluation of national qualifications frameworks, in accordance with the new EU Council Recommendations on the European Qualifications Framework for Lifelong Learning of 22 May 2017. In this terms the conference is an opportunity to get CEDEFOPs expertise in defining the methodology for evaluation of NQFs and good practice example of evaluating and measuring the impact of Irish NQF. As it is widely known, Ireland has one of the oldest national qualifications frameworks in Europe and valuable experience with the systematic evaluations of the Irish National Qualifications Framework.
